The N.C. Forest Service (NCFS) is pleased to offer the Volunteer Fire Assistance Award Program this year. This program is for NC fire departments serving a population of less than 10,000 people. This award program will be provided to qualifying departments chosen during the selection process for purchasing wildland firefighting personal protective equipment, hand tools and approved water handling items. Fire departments that are chosen for this program could receive up to a maximum of \$1,200.00 in matching funds to purchase eligible items. The ability for fire departments to purchase Wildland PPE, hand tools and water handling equipment will provide for increased firefighter safety, more efficient suppression operations and will increase the number of properly equipped firefighters in our state.

Enclosed is an application with the program guidelines and instructions. ***Please read the guidelines and instructions before completing the application.*** If your department serves a population of less than 10,000 people and you are interested in purchasing Wildland PPE, hand tools and/or water handling items through this award program, complete the application and return it to us at the address listed above.

All applications must be postmarked by January 25, 2016.

Please read all of the guidelines below before completing the application

This assistance program administered by the N.C. Forest Service (NCFS) is designed to provide financial assistance to fire departments in NC serving a population of less than 10,000 people for purchasing wildland personal protective equipment (PPE), fire shelters, hand tools and water handling items designed for use while suppressing wildland fires. All fire departments awarded funds under this program shall comply with the following requirements. Failure to comply with these guidelines will forfeit your eligibility for funding and will result in your reimbursement of any or all funds received by your department to NCFS.

Applications must be completed entirely in order to be considered for this program. Incomplete applications will be rejected, and will not be considered for this year's assistance program.

1 – This Award Program will only allow funding for the purchase of the approved items that are listed below:

2 - The PPE purchased must meet the current requirements of NFPA 1977 (2011 edition) Standard for Protective Clothing and Equipment for Wildland Fire Fighting. **No clothing made from Fire Resistant Cotton (FR Cotton) will be purchased with these funds. All clothing must be made from a flame inherent / resistant fiber or material (Nomex®, Aramid, etc.).** Fire Shirts shall not contain less than 5.5 oz./sq. yd. of flame inherent fabric or they will not be approved under this program. Fire Pants shall not contain less than 6.0 oz./sq. yd of flame inherent fabric or they will not be approved under this program. One piece Coveralls/Jumpsuit shall not contain less than 6oz./sq. yd. of flame inherent fabric or they will not be approved under this program.

3 – The maximum amount of funding requested by any fire department shall not exceed \$1,200.00.

Volunteer Fire Assistance Award Program Guidelines and Instructions – Continued

4 – Fire Departments receiving funds under this program shall comply with all Federal Statutes relating to nondiscrimination and all applicable requirements of all other Federal laws, Executive orders, regulations, and policies. These include but are not limited to:

Title VI of the Civil rights Act of 1964 (40 U.S.C. 2000d), which prohibits discrimination on the basis of race, color, disability, or national origin;

5 – On the bottom portion of the application, please list an estimated total cost of eligible items that you intend to purchase with these funds if awarded funding through this program. (*maximum total amount allowed is \$2400*)

6 – No orders should be submitted to us or placed by a fire department prior to receiving award notification. Also, invoices will not be accepted that are dated prior to award notification.

7 – NCFS offers a DOD Purchasing Program for NC Fire Departments in which most of the items authorized for purchase with this assistance program funding are available with the exception of coveralls, fire swatters and axes. If your department is awarded this funding, a DOD Information Sheet and Order Form will be sent to you with your award notification letter for your use if you choose to purchase your items from our DOD Purchasing Program. If your department is awarded funding and you decide to purchase your items through our DOD Purchasing Program, you will be invoiced for 50% of your total purchase once you have received delivery of your items. More information on the NCFS's DOD Purchasing Program for Fire Departments is also available on our web site at http://ncforestservice.gov/fire_control/fc_Dod.htm.

** Please note that DOD prices can change at any time during the year due to contract changes. Therefore, the DOD prices that are on the enclosed price list may be slightly different at the time that you place your order. Since NCFS has no control over the pricing set by DOD, you will be responsible for any differences exceeding your 50% share. Also, there are no returns or exchanges allowed with the DOD Purchasing Program.*

If your department chooses to purchase approved items from sources other than the NCFS DOD purchasing program, then the following requirements must be met before the NCFS will reimburse your 50% portion:

- Vendor must be paid in full by your department for the items purchased.
- A copy of the itemized invoice **and** copy of the cancelled check or bank statement for the items purchased must be submitted to NCFS at the address listed below in section 9.
- Items purchased must be available for inspection by a NCFS.

8 – All completed applications for this Award program must be postmarked by **January 25, 2016**. No faxed copies accepted. A notification letter will be sent to you advising you if funding will be awarded to your fire department or not.
